



FAIRPLAY POLICY

RELATIVE TO THE DYNSEO SUMMER GREAT SENIOR CHALLENGE 2018

Article 1 – Game organization:

DYNSEO (hereafter “the organizing company”)

Siret number: 792354482 whose head office is located at 17 Rue des Belles Feuilles, 75116 Paris, France.

Organize from the 25.06.2018 to the 6.07.2018 a worldwide inter-institutions contest named: “DYNSEO Winter Great Senior Challenge 2018” (hereafter called “the Contest”), as described in the present Fairplay Policy.

Article 2 – General terms of participation:

Participation in the Contest (accessing a round of questions in the application) implies express and unreserved acceptance of the present Fairplay Policy, with all of its stipulations. Any dispute regarding its interpretation will be at the sole discretion of the organizing company.

Article 3 – Game presentation:

The Great Senior Challenge is a contest opposing worldwide institutions on a general culture game over a time span of 10 actual days of game. This Contest is played through a mobile application available on tablet, and specially created for the event by the organizing company. Thus, each day of the contest, institutions get a new round of 32 questions (16 easy and 16 harder).

Alongside this contest, a “Coup de Cœur” prize photo contest is organized. To take part in it, you just have to take a picture of residents playing the contest (do not hesitate to be original). A platform is available to send pictures (without number limitation). All sent pictures will be visible on it and each one will be able to vote for its favorite. Every one can vote (residents, institution staff, families, etc). However, only one vote is authorized per person and per day.

The institution that will get the most “I like” for all of its pictures will be rewarded with a prize (description below).
Votes coming from invalid mails or throwable mails (yopmail for instance) will not be taken in account.

Article 4 – Prizes:

For the Challenge winner institution, in the “assisted living” category and in the “care home” category : a SAMSUNG Tab A tablet and a one year subscription to the Stim’Art CLINT or SCARLETT program.

For the author of the photo that get the “Coup de Cœur” prize : A SAMSUNG Tab A and a one year subscription to the Stim’Art CLINT or SCARLETT program.

Other prizes will be chosen among our partners. Considering that the list of them is not definitive, find them directly on our website: <http://olympiades.dynseo.com>.

Article 5 – Prizes distribution in case of draw:

In case of draw, ex-aequo institutions will be settled the following way:
On a date fixed by the organizing company, the participants will play the “Quizzle” game on the Stim’Art SCARLETT application with the “hard” difficulty. The result that will be taken in account will be the one of the first game played this day. No claim will be received by the organizing company.

Article 6 – Rules respect:

Taking part in the “Dynseo Winter Great Senior Challenge 2018” contest implies fairness, meaning the absolute respect of the rules and rights of the other participants.
Participants refrain to execute or to figure out how to execute any participation process that would be strictly conform to the respect of this Contest principles or of this present Fairplay Policy (looking for right answers on the Internet is not fairplay).
The organizing company reserves the right to eliminate any person who do not totally comply with the present Fairplay Policy.

Convention of proof:

It is understood that the data contained in the organizing company’s information systems shall carry force of proof as to the connection elements and the data resulting from a computer processing relating to the Contest by the organizing company.
